Sir,

With reference to the letter on the subject cited above, I am directed to say that the Government of Assam in Medical Education & Research Department hereby issues No Objection Certificate to the Assam Kaziranga University, Jorhat under North East Knowledge Foundation for starting of Degree and Diploma in Pharmacy course.

This NOC is subject to the following conditions:

1. The NOC does not amount to grant of permission for starting college/course or for admissions which will be granted by the affiliating University as prescribed under the respective rules and regulations.
2. The institution shall fulfill all requirements with regard to physical infrastructure, clinical facility and teaching facility as laid in affiliated University guidelines, **within one year from the date of issue of this NOC.**
3. Periodic reviews will be conducted by Government to verify compliance with all requirements by the institute.
4. Any inspection carried out after issue of NOC will be undertaken by the officials nominated by DME, Assam.
5. All copies of the reports of inspection of DME carried out from time to time will be submitted by the Institute to this Department and the affiliated University immediately.
6. The institute will furnish an agreement with the affiliated/ parent hospital for clinical exposure as required under affiliating University and Government guidelines which will clearly state that such an arrangement will not exceed prescribed ratio, in order to avoid overcrowding and therefore inadequate clinical exposure of students as well as deterioration of patient care in the hospital. This document will be furnished to Government within a month of issue of NOC by State Government with copies to DME and affiliated University.
7. The institute should admit students through Common Entrance Test conducted by SSUHS.

8. The institute shall not admit more students, other than the approved capacity.
9. The institutions shall furnish its annual report to the Government as well as University.
10. The Government may impose any other condition(s) at any time, which shall be binding on the institute.
11. Failure to comply with the above conditions will lead to withdrawal of the No Objection Certificate and action deemed fit shall be taken against the institutions.
